Event Conditions

- **x** Applications will be taken on a first come, first served basis. Early booking is advised to avoid disappointment.
- x The organisers may refuse applications that don't fit the event theme or if too many similar stalls apply.
- x Stands/pitches will be allocated by the Organisers and will not be repositioned on the day of the festival unless absolutely necessary due to health and safety.
- x Pitch dimensions are 4m x 4m.
- **x** All self-erected gazebos/stalls will be inspected for H&S compliance, and vendors must follow any recommendations before trading.
- Please ensure you have enough food/stock to trade for the full day. Stands must remain in place and manned until 5 PM.
- All Stall Holders must have their Stands complete and ready for 10:00 am on Saturday 6th of December. Trading hours are 11 am 5 PM on Saturday the 6th of December.
- x It is the responsibility of the exhibitors to staff their stand at all times and to activate the space.
- x Dismantling of stalls is the responsibility of the exhibitors and will be carried out following closure of the event at 5 PM on Saturday 6th of December.
- **x** There is a limited number of power outlets, please advise should you require one when completing this form. Additional costs apply.
- "All printed materials must remain within your exhibitor stand. Littering or off-stand distribution may result in penalties."

Health & Safety

- x All Food Stall Holders are subject to environmental health regulations. It is the responsibility of each stall holder to be aware of the rules and regulations relating to their particular product. All food licences (where appropriate) must be valid and displayed and a copy must be sent to us with your booking. Due care and attention by Stall Holders and their Agents with regard to stall hygiene is expected.
- x Food sampling with the intent of promoting sales of that product will be permitted as HSE guidelines are followed. Giving away of free full sized product of anything being sold by any vendor at the festival is not allowed.
- x All Stall Holders must have their own public liability insurance and product liability insurance. Proof of insurance is must be submitted at time of booking.
- x People working for Stall Holders and their Agents should be covered by the Stall Holders Insurance.
- Selling of food products from another vendor not at the festival must have pre-approval from the committee.
- **x** Familiarise yourself, and staff attending, with first aid locations.

Cancellation Policy

Refunds will only be given where a replacement can be obtained for your space and a €20 administration charge will apply to all refunds. Cancellations received before 21st of November will receive a 50% refund. No refunds will be processed for cancellations received on or after the 22nd of November.
